Subject: - Zero tolerance Policy against Corruption-reg.

Sir/Madam,

With reference to the subject cited above, it has come to the notice of Ministry of AYUSH, New Delhi, Commission and Medical Assessment and Rating Board for Indian System of Medicine, NCISM that some persons are demanding/collecting money from the colleges by using the name of Commission, NCISM and by giving false assurance that by their effort college will get the permission for the current session. In this regard, it is informed to you that the permission process of the colleges is totally dependent on the concerned Acts and Regulations and policy is issued by the Commission or Medical Assessment and Rating Board for Indian System of Medicine, NCISM time to time. Further, no person/college can get the permission by surpassing the said policy and NCISM Act, 2020 and concerned Acts & Regulations thereunder.

Therefore, you all are directed not to entertain such person/s or group of persons. Further, you are also requested to intimate the MARBISM, Commissioner Ministry of AYUSH or Vigilance officer regarding such activities, if any, so that MARBISM/Commission, NCISM will take serious action against such person or Group of persons under Indian Penal code 1860 or any other relevant law. You may also file FIR against such person and may inform to Anti-Corruption department of concerned state regarding such incidence.

Further it is also informed that no any agents should be entertained by the college for the purpose of processing of permission from the Medical Assessment and Rating Board, NCISM.

Commission is determined not to tolerate such activities/incidence and if any college or any staff of ASU&S College or any other person found to be involved in such type of activities then strong action shall be taken against the college and against such persons under NCISM Act, 2020 as well as under Indian Penal code 1860 or any other relevant law. Further the case shall be forwarded to the Higher Government authority of the concerned state for necessary action.
